

## **UK Full Terms & Conditions**

These Terms and Conditions are between you and Energizer Trading Limited located at Sword House, Totteridge Road, High Wycombe, HP13 6DG England (the “Promoter”) and will be treated as having final say in the event of any conflict or inconsistency with other communications, such as advertising or promotional materials. Plej Sp. z o.o. located at ul. Sielecka, 35 00-738 Warszawa, Poland (the “Administrator”) will be administering this promotion ("Promotion") on the Promoter’s behalf. PHL Group Ltd located at Dragon Works Ind Est, Henfaes Lane, Welshpool, SY21 7BE England (the “Distributor”) will be delivering the Gifts on the Promoter’s behalf. Entry instructions form part of the Terms and Conditions, and by participating, all entrants are considered to have accepted and be bound by the Terms and Conditions. Please keep a copy for your information. The Walt Disney Company and its affiliated companies (collectively “**Disney**”) and Funko LLC and its affiliated companies (collectively “**Funko**”) are not responsible for the administration of the Promotion, the collection of entries, selection of winners, or the fulfilment of prizeing. You are providing information to Promoter and not to Disney and Funko. Any questions you have regarding the Promotion should be directed to Promoter and not Disney or Funko.

### **Eligibility**

This *Energizer*® Promotion is open to all residents of the United Kingdom, including Guernsey, Isle of Man and Jersey, aged 18 or over, excluding employees of the Promoter and Administrator, Disney, Funko, their affiliates or agents, the immediate families of such employees and any other person connected with this Promotion. Energizer will not be responsible for any under-age entries.

1. Purchase is necessary. **Please retain an itemised receipt that states the time and date of purchase prior to entry, but within the Promotion Period, as this may be required for validation and in order for a claimant to receive their Gift.** Internet access, local mobile number and email address are required.
2. **Promotion Period:** This Gift with Purchase is open from 00.01 BST on 1 October 2025 and closes at 23.59 GMT on 31 January 2026 inclusive or until the first 12 Gifts per day have been claimed. Thereafter, the promotion will re-open at 00:01 BST the following day within the Promotion Period.
3. **Claim Instructions:** This Gift with Purchase is exclusive to customers who:
  - a. Purchase any *Energizer*® batteries, battery chargers or torches within the Gift with Purchase Promotion Period.
  - b. Visit [energizerpromo.com](https://energizerpromo.com) and navigate to the Energizer x Zootropolis 2 page (the “Energizer Promotional Page”), enter their product barcode, full name, email address, residential address and local mobile number.
  - c. Customers will receive an email to the email address provided asking them for verification by clicking a link. Customers will also receive a text which contains an activation code to the mobile number provided and will be asked to input this number on the Energizer Promotional Page as part of the verification process on the link provided.
  - d. When customers have completed both verification steps, customers will receive an email confirming that they will be receiving their Funko Pop! Disney Zootropolis 2 (“**Gift**”) within 90 days.

All Promotion claims received after the end of the Promotion Period are automatically invalid.

4. The Promoter will endeavour to send Gifts out within 28 days of a valid claim. In the unlikely event that a Gift doesn't arrive within 90 days of a valid claim, recipients will have a further 28 days to inform the Promoter by emailing [support@Z2.energizerpromo.com](mailto:support@Z2.energizerpromo.com). If a recipient does not inform the Promoter within this time frame, the Promoter will reserve the right to not reissue the Gift.
4. **The Gift:** A minimum of the first 12 claimants per day who correctly follow the Claim Instructions will receive 1 x Funko Pop! Disney Zootropolis 2 ("Gift"), which has a value of £13. Unclaimed Gifts will be rolled over to the next day during the Promotion Period. Each claimant will receive one of the following Funko Pop! Disney Zootropolis 2 characters, allocated randomly. There are equal numbers of each character.
  - a. Nick Wilde (Fox); or
  - b. Judy Hopps (Bunny).
5. **Further Gift Details:**
  - a. The Promoter is not liable for any Gifts once distributed/dispatched to a claimant and the Promoter will not be responsible for any Gifts not received, broken or lost in transit.

One itemised receipt per claim must state the time and date of purchase, which must pre-date the claim date and time, but be within the Gift with Purchase Promotion Period. Offer is only available whilst stocks of the Gift last.

Your personal data will be processed based on the legitimate interests of the Promoter (a) for no longer than is necessary to conduct the Promotion and (b) after the Promotion, only to defend against possible claims of participants, or to comply with legal obligations, relating to the Promotion. By participating in the Promotion, you will receive emails from the Administrator in confirmation of your entry and about the Promotion. If you are a claimant, the Administrator

will use your personal data to deliver the Prize. You have the right to access, rectify, transfer, and delete your personal data and to object to or limit the processing of your personal data. The Promoter does not intend to transfer your personal data to third countries. ## **General**

10. It is a condition of the Promotion that the claimant agrees to be bound by these Terms and Conditions, and in particular that the decisions of the Promoter on any matters whatsoever arising out of or connected with the Promotion are final.
11. The Promoter seeks to run a fair and secure promotion and prevent abuse and cheating. If you participate in a way that is not consistent with these Terms and Conditions, your claim (and any of your associated aliases) will be disqualified. Any Gift awarded may be void and recoverable, and the Promoter reserves the right to bar you from participating in future promotions for a period of at least six months. For this reason, the Promoter reserves the right at any point to:
  - a. Verify the eligibility of participants by requesting such information it considers reasonably necessary for this purpose. A Gift may be withheld until verification is completed.
  - b. Disqualify claims that are not made directly by the individual participating in the Promotion.
  - c. Disqualify claims made using anonymous email services such as, but not limited to, GuerillaMail, Dispostable or Mailinator.
  - d. Disqualify bulk claims from individuals, trade, consumer groups or third parties, incomplete entries and entries submitted by macros or other automated means.

12. The Gifts are non-transferable. There are no alternatives to the Gifts offered. In the event of unforeseen circumstances, the Promoter reserves the right to substitute the Gift for an alternative of equal or greater value.
13. This Promotion is in no way sponsored by Funko LLC or ©Disney 2025. All Rights Reserved. The Walt Disney Company, Pixar and each of their respective parent, affiliates, and subsidiaries are not responsible for the Promotion, administration or execution of the Gift with Purchase.

By entering you are providing your information to the Promoter and not to these entities. The entities are not responsible for any element of this Promotion.

14. The Promoter will do all that it reasonably can to ensure that the Energizer Promotional Page is functioning correctly throughout the Promotion Period. However, the Promoter will not accept responsibility for Promotion claims that are lost, delayed, corrupted, damaged, misdirected or incomplete or which cannot be delivered for any delivery, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind or other reason. Proof of sending will not be accepted as proof of receipt. The Promoter does not guarantee continuous or secure access to the Energizer Promotional Page.
15. In participating in the Promotion, the participant confirms that they are eligible to do so and eligible to receive the Gift if they are a claimant. The Promoter reserves the right to verify the eligibility of claimants including but not limited to requiring proof of a claimant's identity, age, place of residence and/or that they are not employed by the Promoter or its Agent (which must be provided within 14 days). None of the Promoter, and its respective associated agencies and companies, Funko, or Disney and its affiliates will be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense or damage which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Promotion or accepting or using a Gift, except for any liability which cannot be excluded by law. Nothing will exclude the Promoter's liability for death or personal injury as a result of its negligence.

In the event of circumstances outside the reasonable control of the Promoter, or otherwise where fraud, abuse, and/or an error (human or computer) affects or could corrupt or affect the proper operation of this Promotion or fulfilment of Gifts, and only where circumstances make this unavoidable, the Promoter reserves the right to cancel, suspend or amend the Promotion or these Terms and Conditions, at any stage, but will always endeavour to minimize the effect to participants in order to avoid undue disappointment.

None of the Promoter, Disney, Funko, and their respective parents, subsidiaries, and affiliates, and each of their respective officers, directors, shareholders, employees, agents, representatives, assigns and successors-in-interest will not be liable for any failure to comply with its obligations or any delay in performing its obligations within these terms and conditions if an act, omission, event or circumstance occurs caused by (but not limited to) global or

regional health crises, weather conditions, fire, flood, strike, hurricane, industrial dispute, war, terrorist activity, hostilities, political unrest, riots, civil commotion, epidemic, pandemic, famine, plague or other natural calamities and acts of God, or any other circumstances beyond the reasonable control of the Promoter.

20. A claim must be made directly by the individual participating the Promotion. Bulk claims from trade, consumer groups or third parties will not be accepted. Incomplete or illegible entries and entries submitted by macros or other automated means together with entries which do not satisfy the requirements of these Terms and Conditions in full will be disqualified and will not be counted. If it becomes apparent that a participant is using a computer(s) to circumvent this condition by, for example, the use of 'script', 'brute force', masking their identity by manipulating IP addresses, using identities other than their own or any other automated means in order to increase that participant's entry in a way that is not consistent with the Terms and Conditions of the Promotion, that participant's claims will be disqualified and any Gift confirmation will be void. Participants are not permitted to claim using anonymous email services such as, but not limited to, GuerillaMail, Dispostable or Mailinator.
21. If any part/s of these Terms and Conditions should be determined to be illegal, or are legally ruled to be invalid or otherwise unenforceable then the remainder will not be affected and will continue in full force and effect.
22. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of these rights.
